#### NANOVESICLES FOR SKIN DELIVERY

We carry out efficacy tests using human skin explants to simulate real life situations of penetration and cosmetic activity.


By way of example we hereunder show some of the results obtained.

#### "EX VIVO" AND "IN VIVO" TESTS

We also carry out ex vivo and in vivo tests to monitor the improvement in efficacy of the encapsulated actives, as a result of our delivery systems.

#### **VEGAN DDS PURE RETINAL** (EX VIVO / ANTI-AGING ACTIVITY)

- Gel with 5% Vegan DDS Pure Retinal vs gel with same concentration of free retinal.
- Human organotypic skin explant cultures (hOSECs)
- To replicate skin aging, a corticoid cocktail was administered to the growing skin medium.
- Topical application over a period of 9 non-consecutive days







# EFFICACY STUDIES 03.

#### **VEGAN DDS DIOSMIN** (IN VIVO SKIN ERYTHEMA STUDY)

- 20 volunteers
- Capsaicin occlusive patch for 1 hour to induce irritation
- Treatment with gel containing 5% Vegan DDS Diosmin
- Skin erythema levels were quantified using Mexameter®







# (UV AND POLLUTION PROTECTIVE EFFECT)

- Gel with 5% Vegan HDS Keradefence vs gel with same concentration of free actives
- 30 caucasian hair segments of 1 cm lenght per studied condition Ð
- Negative control and treatment groups were damaged with urban particulate matters + UV (4 cicles of 6 h exposition)
- Measurement of keratin structural integrity by means of birefringence values

#### VEGAN CDS GLYCOLIC (EVALUATION OF THE ANTI-PEELING EFFECT)

Tested on 22 volunteers aged 30 to 55 with normal to sensitive skin, proving its efficacy and gentle touch. Participants applied the product twice daily (morning and night) over a 28-day period.

Using advanced tape-stripping analysis, we measured the number and size of corneocytes—the skin's outermost cells—to assess hydration and overall skin health. When skin is dehydrated or damaged, it sheds large, thick corneocytes, signaling an impaired barrier.

#### • - 27.33% scaling (after 14 DAYS of product use)

#### • -28.43% scaling (after 28 DAYS of product use)

The Vegan CDS Glycolic product shows no immediate sign of anti-peeling effect but does show a progressive cell renewal effect which increases with continued use.




Image of peeling (Corneofix + Visioscan) at T0
